SPECIAL VILLAGE BOARD PROCEEDINGS**

Pursuant to due call and notice thereof, a Special Village Board meeting was held on Thursday, November 20, 2025 in the Municipal Office - 102 W Main Street. Darren Peterson called the meeting to order at 6:30 PM. Roll Call: Luke Loescher, Dalton Spry, Mark Kuhl, Joe Peterson, Nikki Froehlich, Lee Williamson, and Darren Peterson were present. Attorney Paul Mahler – Bakke Norman Absent. Also present was Jodi A Gilbert - Clerk/Treasurer. The Osceola Sun Newspaper and the Inter County Leader Newspaper were absent. Salute to the Flag was given.

CITIZEN COMMENTS: Darren Peterson called for Citizen Comments. No Citizens Present. No comments were made. Darren Peterson closed Citizen Comments.

PUBLIC HEARING ON THE PROPOSED 2026 VILLAGE BUDGET

1. Announcement – The Village Board was informed that the proceedings would be tape recorded.
2. Darren Peterson called to order the Public Hearing – Roll Call was taken. Luke Loescher, Dalton Spry, Mark Kuhl, Joe Peterson, Nikki Froehlich, Lee Williamson, and Darren Peterson were present.
3. Darren Peterson gave the announcement of Publication: The Public Hearing was published in The Osceola Sun November 5, 2025 and Posted/Web Page on October 31, 2025.
4. Darren Peterson commented that the detail for the 2026 Budget was in your packet. No comments were made.
5. Darren Peterson called for any public comments. Nothing was stated/No Citizens Present.
6. Motion Joe Peterson/Nikki Froehlich to adopt the 2026 Budget and set the Levy at \$541,344.00.
7. Darren Peterson called for any other discussion/comments/concerns regarding the 2026 Budget. Nothing was stated.
8. Darren Peterson stated for the record there were no amendments/changes to the 2026 Budget at this time.
9. Darren Peterson called for a Roll Call Vote regarding the Motion to adopt the 2026 Budget and to set the Levy at \$541,344.00. All board members present voted yes. Motion Carried. Darren Peterson stated the 2026 Budget is adopted.
10. Motion Joe Peterson/Spry to adjourn the Public Hearing at 6:35 PM.

FINANCE: Motion Joe Peterson/Froehlich to approve placement of all delinquent utility accounts and special charges in the amount of \$34,729.69 on the 2025 Tax Roll. It was stated that Polk County settles with the Village in whole each year. All in Favor. Motion Carried.

Motion Joe Peterson/Loescher to set the 2025 Village of Dresser Mill Rate at .007196932. No discussion took place. All in Favor. Motion Carried.

OTHER BUSINESS:

Motion Darren Peterson/Nikki Froehlich to approve estimate from Meyer Tree Service in the amount of \$1,800.00 to take down trees on the walking trail. Jesse will do the cleanup and Meyer is planning to just drop the trees. No other discussion took place. All in Favor. Motion Carried.
