

**RESOLUTION NO. 02-2017**

**RESOLUTION ADOPTING FAIR HOUSING ORDINANCE**

AN ORDINANCE TO CREATE SECTION 19.17 OF THE VILLAGE CODE OF THE VILLAGE OF DRESSER ADOPTING WISCONSIN STATUTES, SECTION 106.50, AS AMENDED, RELATING TO THE EQUAL RIGHTS OF ALL PERSONS TO FAIR HOUSING, AND PROVIDING MEANS FOR THE IMPLEMENTATION AND ENFORCEMENT THEREOF. THE VILLAGE OF DRESSER DOES ORDAIN AS FOLLOWS:

Section 19.17 is created to read as follows:

**FAIR AND OPEN HOUSING**

WHEREAS, the Village Board of the Village of Dresser recognizes its responsibilities under Section 106.50, Wisconsin Statutes, as amended, and endorses the concepts of fair and open housing for all persons and prohibition of discrimination therein;

THEREFORE, BE IT ORDAINED THAT:

- 1) The Village Board of the Village of Dresser hereby adopts Section 106.50, Wisconsin Statutes, as amended, and all subsequent amendments thereto.
- 2) The officials and employees of the Village of Dresser shall assist in the orderly prevention and removal of all discrimination in housing within the Village of Dresser by implementing the authority and enforcement procedures set forth in Section 106.50, Wisconsin Statutes, as amended.
- 3) The Village Clerk shall maintain forms for complaints to be filed under Section 106.50, Wisconsin Statutes, as amended, and shall assist any person alleging a violation thereof in the Village of Dresser to file a complaint thereunder with the Wisconsin Department of Work Force Development, Equal Rights Division, for enforcement of Section 106.50, Wisconsin Statutes, as amended.

The above resolution has been authorized by the governing body of the Village of Dresser Resolution No. 02-2017, dated on this 1<sup>st</sup> day of May, 2017.
