RESOLUTION #04-2015

**A RESOLUTION TO DISCONTINUE A PORTION OF WEST MAIN STREET IN
THE VILLAGE OF DRESSER**

THE VILLAGE BOARD of the Village of Dresser, Polk County, Wisconsin, having met in duly noticed regular session at 6:30 p.m., on June 1, 2015, upon motion duly made and seconded, does hereby adopt the following:

WHEREAS, the Village Board of the Village of Dresser finds that the portion of Main Street west of State Highway 35 will never be extended; and,

WHEREAS, this portion of road within the corporate limits of Dresser is currently classified as a minor street 1,000 feet or more in length with a road Right Of Way designated at 60 feet; and,

WHEREAS, Main Street west of State Highway 35 is actually a minor street less than 1,000 feet in length which allows a Right Of Way of 50 feet; and,

WHEREAS, a petition has been filed by all of the abutting property owners requesting a reclassification of Main Street west of State Highway 35 to a minor street less than 1,000 feet with a road Right Of Way to be 50 feet; and,

WHEREAS, the Village Board finds the petition in order as required by Wisconsin State Statutes Section 66.1003(2012-13)

NOW, THEREFORE, BE IT RESOLVED that

1. The Village Board of the Village of Dresser declares that a portion of Main Street west of State Highway 35 be discontinued and reclassified as a minor street less than 1,000 feet in length with a road right of way of 50 feet.
2. A Public hearing on the passage of this Resolution shall be held before the Village Board on the 13th day of July 2015, at 6:30 p.m., in the Dresser Municipal Building.
3. Notice of the public hearing shall be published as a class 3 notice under ch.985, Wisconsin Statutes.
4. Further notice of the public hearing shall be served on owners of all of the frontage of the lots abutting Main Street west of State Highway 35 and the owners of lots within 2,650 feet of the end of the portion to be discontinued at least 30 days prior to said public hearing in accordance with Sec. 66.1003, Wisconsin Statutes.


