

**Village of Dresser  
Resolution #06-2021  
To Establish Ward Boundaries Following the 2020 Census and to also  
Establish the Common Polling Place for the Village of Dresser**

WHEREAS, Wisconsin Statutes Section 5.15, requires all cities, villages, and towns with a population of 1,000 or more to establish municipal wards based on the results of the 2020 census, and

WHEREAS, the estimated population of the Village of Dresser on January 1, 2021 is 913, and

WHEREAS, Section 59.10(3)(b) of the Statutes requires that each county board adopt and transmit to each municipal governing body in the county a tentative county supervisory district plan dividing the county into supervisory districts of equal population,

THEREFORE, BE IT RESOLVED, that the Village of Dresser is not required to establish wards due to the fact that the Village of Dresser's population falls below 1,000, and

THEREFORE, BE IT RESOLVED, that the following ward(s) are hereby created to establish the supervisory districts for Polk County, and approved by a majority of the governing body of the Village of Dresser:

Ward 1: - Population 913(DOA – Demographic Services Center Estimated Population January 1, 2021): The Village of Dresser's Corporate Boundary serves as the line for the Ward of the Village of Dresser

BE IT FURTHER RESOLVED, that the above ward(s) boundaries are outlined and identified on the attached map, which is incorporated and made a part thereof, and

BE IT FURTHER RESOLVED, that for all voting purposes, the above ward(s) will be combined using one common polling place, as required by law.

The designated polling place will be:

Dresser Community Hall – 115 W Main Street, Dresser WI

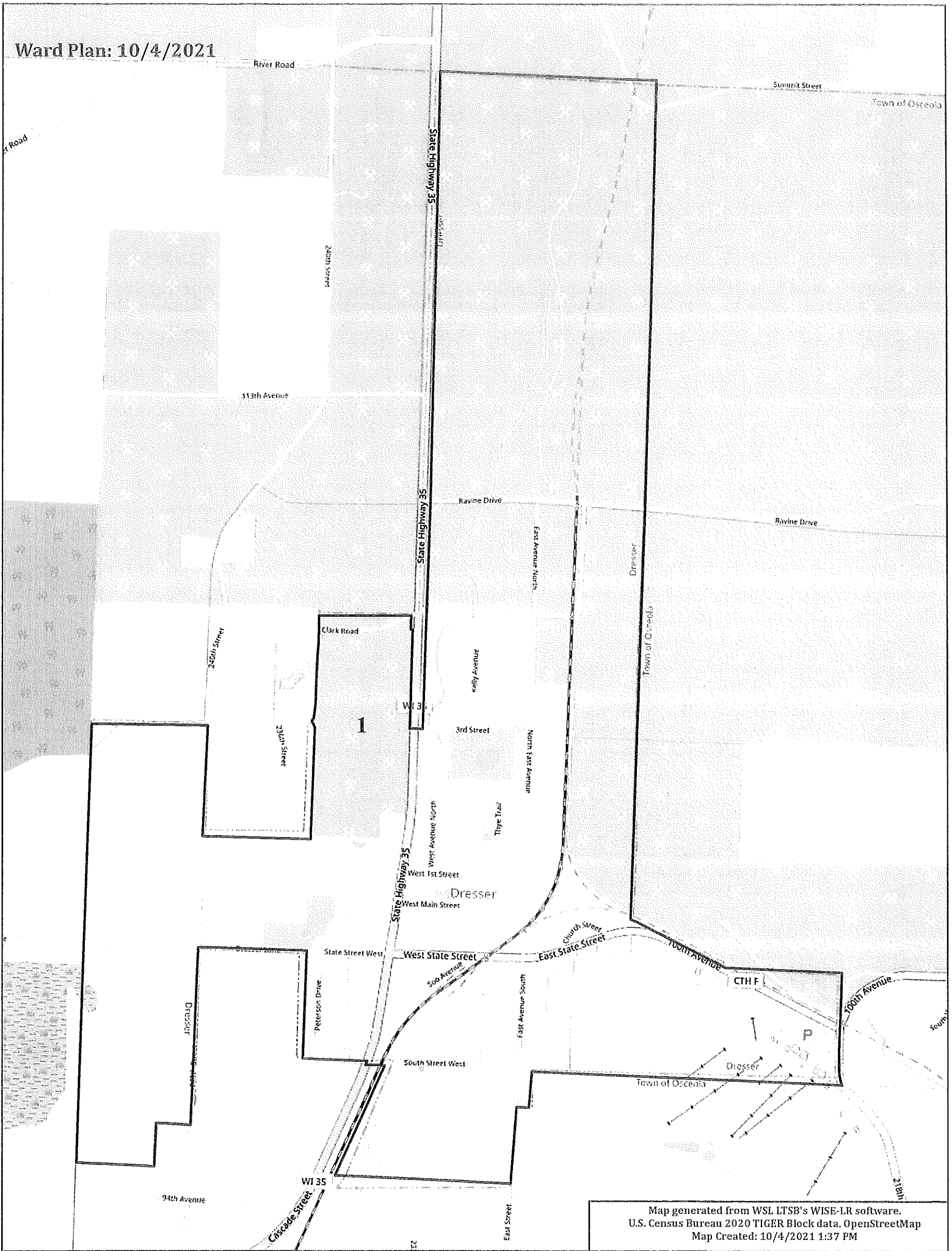
